The Board of Logan County Commissioners met in Regular Session with Chairman Mark Sharpton presiding, Member Monty Pearcy present and Member Mike Pearson present and transacted the following:

The Agenda was posted at 3:01 P.M. on September 2, 2009 and was posted at the Courthouse and Annex.

Present at the meeting were: Sean Abbananto, Jill Graham, Dennis Hunger, Mary Jo Messelt, Steve Rowley, Richard Trice, Stacy E. Williams, Rob Hudson and Mary Murphey.

The meeting was called to Order by the Chairman.

The flag salute was given.

#### **MOTION ADOPTED TO APPROVE MINUTES**

Monty Pearcy made the motion which was duly seconded by Mark Sharpton with the voting as follows: Sharpton-AYE, Pearcy-AYE and Pearson-AYE;

THAT, the minutes of August 31, 2009 be approved.

Steve Rowley, CEO of Logan Medical Center, presented his monthly report. He said that volume has increased more than any other time in the past. He said that the total revenues were up over budget and that expenses were less than budget. Mr. Rowley stated that he expects swing beds to increase as other hospitals send patients to LMC. Mr. Rowley explained the difference between bad debt, those who have income and do not pay, and charity, those who do not have the means to pay. He said those in the bad debt category are referred to collection where the hospital will see a percentage of the debt returned.
